- I. Board Discussion
  - 1. Home School Academic & Athletic Participation.

We discussed the different ways that home school kids can participate in sports or in classes we offer. Right now we do not have a policy about how we offer our district to home school kids. We will eventually have to look into making one. We will bring this discussion to a workshop.

### 2. Active Shooter Discussion

In light of recent school shootings Klara requested that we have a discussion to refresh our memories to see what we have in place for school safety. Mr. Tapio gave us an overview on what the schools procedures are. We are getting more cameras added to the elementary school. John added that our students need to know what to look for in behaviors that should be reported. He also asked if our students take the active shooter training. Bruce said they don't but the teachers do talk to them about what they can do to protect themselves in the event of an intruder. A suggestion was made to invite our substitute teachers to the active shooter training.

# 3. Superintendent/ Principal Contract

Mr. Tapio gave us a copy of his contract that we can look over and bring questions to him before we vote on his renewal in March. Bruce noted that the evaluation portion of the contract needs to be reworded. Also under "Extensions" we need to change March 30th to June 30th. Kelly asked if Bruce could put a specific date that he would let the Board know that he is coming back the next year. The contract will now say, "By the end of January". It is requested to talk more about the contract during our March Workshop meeting.

# 4. M & M Community Foundation Information It came to Mr. Tapio's attention that the M & M Foundation is two different funds. Bruce is looking into how to best utilize the schools funds.

Jessica would like to have a vote in March to omit the Boards stipend for the year 2018.
